Billy Anderson conducted the safety briefing.



## **Old Business:**

Carol's Update:

Carol and Pam Fogle attended Fathers Matter event in Council Bluffs. The location had been changed due to water issues and was relocated to lowa Western, and although they had good signs to the event, there was not much of a crowd due to construction on the campus.

She advised that she will be going to the NAC Meeting which will be combined with OLI meetings September 10<sup>th</sup> and 11<sup>th</sup>.

#### **FRA Competitive Grant**

Carol updated that Nebraska did not qualify for the 2019 grant. There were 26 states that applied for the grant. Rachel and Wende said they will work with us in the future to help Nebraska apply for future grants.

#### **ENS Video from Amtrak**

Deb made 15 thumb drives with the new ENS video from Amtrak (Critical Junction) and the old video (Cheating Death) along with PowerPoint presentations of Operation Lifesaver training and these were passed out to presenters at the meeting.

### **New Business**

#### **Omaha Storm Chasers Event**

Carol reminded attendees that July 21, 2019 was the annual Omaha Storm Chaser event in Papillion. Carol will pay for ball tickets for participants that will help with the safety booth at the game.

## Nebraska State Fair Update

Carol advised that the application was filed, and Deb updated that this year we have been given additional space to include one of the crash cars directly behind our mobile training trailer. The vendor in front of our trailer for fair attendees coming from the south will be smaller this year and as a result our trailer should be easier to see.

## Rail Safety Week (see attached documents)

Deb presented an update on National Rail Safety Week (Sunday Sept 22<sup>nd</sup> through September 28<sup>th</sup>). The committee reviewed the daily themes from last year and the draft copy for 2019. Jeff Schmid and Deb presented a role play of the role of OLAVs and Law Enforcement in positive crossing initiatives for Operation Clear Track. Deb and Carol will be coordinating a committee on preparing for the week event. Law Enforcement need to be contacted and communicated on their role in this National event. The first event Nebraska will be celebrating will be Streets Alive in Lincoln with the Mobile Training Trailer. A presentation will be also given at the Safety Advocates meeting on 8/8/19 regarding National Rail Safety Week.

## Streets Alive (document attached)

Megan provided the Committee an update that the event will be held in Cooper Park (5<sup>th</sup> and D Streets in Lincoln) in the South Salt Creek neighborhood on Sunday, September 22<sup>nd</sup>. Nebraska Operation Lifesaver will have the mobile training trailer available to the public, along with many other safety vendors. Exhibitors will be lining a two-mile route to encourage participants to walk the entire route. Megan will promote Operation Lifesaver with the promotional materials and social media badges for the 2019 event. Great opportunity for us to start Rail Safety Week.

## **Guest Speaker – Tim Welch**

Tim presented a very moving talk about a horrific rail incident he had on February 6, 1992. He had received a call from his mom to get downtown as soon as possible. He made the decision that since the railroad tracks were blocked that he would go between the cars, but unfortunately it was double track and on the other track was two engines pulling a box car. The engineer thought he had grabbed Tim, but he was dragged for over 300 feet and lost his arm at the elbow and his leg off at the knee at the scene. Fortunately for Tim his doctor was at the crossing waiting for the train and prepped him for his emergency helicopter ride to Omaha. His mother was a nurse and his stepdad a paramedic. He was life flighted to Creighton with a 7% chance of survival. He stated that even if he had the opportunity to go back and do it over, he wouldn't as it has made him the person he is today. Tim is now a motivational speaker, has written a children's book about bullying, and has starred in several movies as well. He has just joined Nebraska Operation Lifesaver as a presenter. As Tim stated when Deb provides a presentation it gives students one perspective with words, but when Tim tells the story it is heard as well as being visual as to what can happen at railroad crossings, and his goal is to get the important message he learned out to kids and he especially has a goal for his own community of Blair. We are very happy to welcome Tim to our team.
